## WSCUC APPROVES FIRST ROUND OF ACCREDITATIONS UNDER STREAMLINED ALTERNATIVE MODEL

## **Eight Institutions Pioneer Thematic Pathway for Reaffirmation**

At its February 2021 meeting the WASC Senior College and University Commission (WSCUC) granted reaffirmation to the first set of institutions pursuing its alternate route to renewed accreditation, known as the Thematic Pathway for Reaffirmation (TPR). This streamlined approach, approved in June 2017, is available to high-performing institutions. The following eight pioneering TPR institutions were affirmed for the maximum ten-year accreditation period:

- California Institute of Technology
- · California State University, Long Beach
- Loma Linda University
- · Naval Postgraduate School
- Pardee Rand Graduate School
- Samuel Merritt University
- Soka University of America
- · University of California, San Francisco

TPR is an alternative accreditation renewal pathway designed for institutions that demonstrate consistent evidence of healthy fiscal condition, strong student achievement indicators, and sustained quality performance. This new path is as rigorous as the regular institutional review with a special timeline during which institutions can focus on self-selected themes that advance their mission, coordinate with their strategic planning, and promote institutional improvement.

This initial TPR cohort reflects the breadth of WSCUC's institutional membership as it includes schools that are public and private, large and small, comprehensive, highly selective, and graduate, and specialized in fields as diverse as public policy, medicine and health, and naval leadership. To date thirty-one institutions (15% of the universe of 207 WSCUC-accredited institutions) have been approved to pursue the TPR, representing the inaugural institutions and others (including Cal Arts, Cal Poly San Luis Obispo, CSU Northridge, Pepperdine and Stanford Universities, Occidental, Pomona and Whittier Colleges, University of Hawaii at Manoa, University of San Diego, and University of Southern California) engaged now in review.

WSCUC Chair Phil Doolittle said, "TPR speaks to the partnership between institutions and WSCUC. This differentiated process and project focus make sense for institutions with strong track records of performance and outcomes. It's the kind of flexible, responsive approach that WSCUC values."

The design process for the new TPR approach began in 2014 when there were calls for risk-sensitive approaches to accreditation, including from the US Department of Education, American Council on Education, and others. WSCUC conducted a development and review process, including open discussions at its annual Academic Resource Conference, a working group of institutional representatives, and written feedback from the region.

Jamienne S. Studley, WSCUC President, added, "Our growing use of student success outcomes and benchmarking data helps WSCUC concentrate on improvement, results and burden reduction. We appreciate the collaboration of the first TPR schools to turn this innovation into reality."
