

Consumer Information Disclosure for LLU Clinical Psychology Psy.D. program

The following table is presented so as to provide interested stakeholders with information about whether the LLU Clinical Psychology Psy.D. program meets educational requirements for licensure in the jurisdictions noted in the table. For each jurisdiction, the Clinical Psychology Psy.D. program requirements were compared to each jurisdiction’s requirements for licensure as summarized in the Association of State and Provincial Psychology Board’s (ASPPB) document entitled Consumer Information Disclosures, the link for which can be found here:
